## **Children & Families Served**

HACAP was funded to serve 867 children, including services to pregnant women, during the 2023-2024 program year.

In the 2023-2024 Head Start/Early Head Start program year we served 719 children and pregnant women:

- 687 Head Start children
- 187 Early Head Start children and 4 pregnant women

## **Health & Nutrition**

#### **Disability/Mental Health**

HACAP continues to partner with our local AEA's to provide Disability and Mental Health Services to children and families. Our nine counties are served by three AEA's: Grant Wood, Keystone, and Mississippi Bend. Through the child find process children are referred and evaluated for special education services if needed. We work with our local school districts to coordinate the best programming option to meet the child and family needs. Mental Health Consultants from the AEA work closely with staff to observe and provide feedback related to Mental Health/Social Emotional skills. In the 2023-2024 school year, we served 76 children in Head Start with IEP's and 30 children in Early Head Start with an IFSP.

#### **Nutrition**

HACAP Head Start values the role we play in helping children develop healthy eating habits that will last them a lifetime. Our staff receive on-going training on how to be a positive role model during family-style mealtimes. Teachers regularly incorporate nutrition education activities into their lesson plans. Some of our nutrition education activities and meals are supported by Farm to Early Childhood Education grant funds, which allow us to purchase fresh food from local farmers. We provide information to parents that supports their efforts to provide nutritious meals for their family at home, including information about WIC and SNAP benefits, as well as other community food resources. Head Start continues to receive reimbursement for meals through the USDA's Child and Adult Care Food Program. We were pleased to add an additional cook position as our Jane Boyd center's food service operation changed from catered meals to on-site meal preparation due to the increase of children served at that center. The Jane Boyd center has a kitchen that is well equipped for the preparation of meals for the three classrooms.

## **School Readiness**

Each Head Start location works with the local school district to provide parents of children who will be entering Kindergarten with information about kindergarten registration/round-up events in the school district the child will be attending the following fall. These conversations start at the first home visit and continue throughout the school year. They talk with parents about obtaining the child's birth certificate and taking proof of residency with them to the registration/round-up. Staff also provide parents with the documents that they need for these events (current physical and immunization card, vision screening and hearing screening). Teachers also identify Kindergarten Readiness Activities in their weekly lesson plans. These activities might include teaching social skills, like getting a friend's attention or sharing or teaching self-help skills, like hand washing and zipping up coats.

All Head Start and Early Head Start children are assessed using My Teaching Strategies Assessment. We continued to use The Gold Resource Guide, a resource for teachers to help them with documentation and completing assessments in My Teaching Strategies. The resource guide allowed teachers to be better prepared for each assessment period. Head Start aged children are assessed in the Fall, Winter and Spring. Early Head Start aged children are assessed in the Fall, Winter, Spring and Summer. The assessment focuses on social/emotional, physical, language, cognitive development, literacy and mathematics. The graphs below show the percentage of children meeting and/or exceeding expectations for their age at the fall and spring checkpoints.

The Head Start graph shows growth in every area between the Fall (blue line) and Spring (orange line) assessments. The lowest area of growth was in physical development with 13 points and the highest area of growth was in mathematics at 30 points.





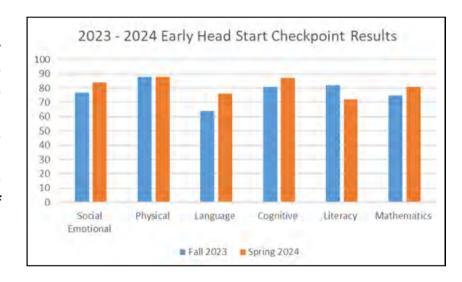


## **School Readiness (Continued)**

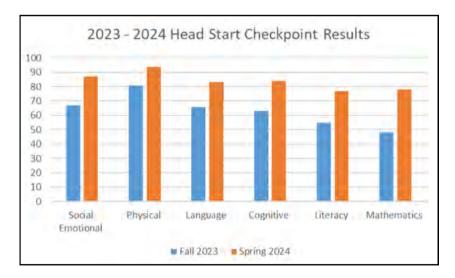
The Head Start graph shows growth in every area between the Fall (blue line) and Spring (orange line) assessments. The lowest area of growth was in physical development with 13 points and the highest area of growth was in mathematics at 30 points.

The Early Head Start graph shows growth in every area except Literacy between the Fall (blue line) and Spring (orange line) assessments. The Early Head Start and Head Start programs are fluid programs, children move from Early Head Start to Head Start and children enter Early Head Start throughout the year.

When children enter Early Head Start, they are typically younger and therefore their skills are lower than the skills of the children who they are replacing who moved to Head Start. The lowest area of growth was in literacy which went down by 10 points and the highest area of growth was in language at 12 points.



During the 2023 - 2024 Program Year we offered the new modules of PBIS for Preschool to all staff. Two of our staff were trained to be PBIS Infant Toddler Trainers and two were trained to be PBIS Preschool Trainers. We are implementing an ongoing PBIS Training Plan for groups in the 2024 -2025 Program Year.



## Parent & Family Community Engagement

In Head Start we believe that parents are a child's first and most important teacher and Head Start serves not just children but the child's whole family. Engaging families in our services and learning about their needs and goals is a key part of what we do in our daily interactions with parents. Each year staff complete a Family Summary with each interested family to help us get to know them better. After discussing this information parents and staff members work together to set up Family Partnership Agreements related to the goals the family has for themselves and for their children. Resources and support that are available to the family within the agency and the community are shared and included in the goal to help support them in successfully meeting their goals.

Over the course of the school year 598 families worked with our staff members to complete a Family Summary. Those Family Summaries were used to help 549 families set 569 Family Well Being Goals and 711 School Readiness Goals for their children. 86% of the goals set were met fully or partially.

Parent - Child activities are held at each of our centers during the school year to encourage parents to participate in activities in their child's classroom. Popular events this past school year included families dying t-shirts, a toddler prom, various arts and crafts activities and end of the year celebrations.
