
YTD Distribution



TEFAP in detail

- The Emergency Food Assistance Program (TEFAP): USDA Purchased Commodities distributed to food banks. This is mandatory funding from Farm Bill. Mandatory Funding = the government is required to do this by law from an act of congress. TEFAP has existed since 1983, and recent disruptions have not affected, and will not affect, these foods coming in.
- <u>Section 32 Bonus</u>: Commodities purchased by USDA based off the needs of, and surplus, within US Ag Industry. *Not funded through TEFAP Appropriation process Permanent funding since 1935. Most funding goes to childhood nutrition and forestry the remaining funds can be spent at the discretion of the Secretary of Agriculture. There was a recent \$200+ million investment via this source shortly after the CCC funding was canceled.

Commodity Credit Corporation (CCC): Government owned/operated corporation that finances authorized programs supporting US Ag Industry. The Secretary of Agriculture currently dictates where this spending is utilized. This money has only been used recently to support food banks and isn't promised in any year.






